Dear Mr. Saltzman:

At the Fourth Session of the American Jewish Conference held in Chicago, November 29 - December 1, the delegates ordered that the Interim Committee assemble within thirty days of the session to launch plans for the organization of the permanent body to succeed the Conference.

In accordance with that decision, I am calling the first meeting of the Interim Committee on Monday, December 29, 10:30 a.m., at the Hotel Pennsylvania, 33rd Street and Seventh Avenue, Conference Room 2.

It is of great importance that there be a full attendance at this meeting since the agenda will include, among other matters, the following:

- 1) Election of officers
- 2) Election of a national Board of Elections and agreement on its terms of reference
- 3) Continuation of the work of the American Jewish Conference and its relations with other organizations pending the establishment of the new body
- 4) Naming of standing committees
- 5) Disposition of matters referred by the Fourth Session

I earnestly hope that you will find it possible to attend this meeting. I am sure that you will agree with me that if this undertaking is to succeed, it must have the broadest possible support from the very outset.
